Bill filing began on December 1 which means the 2024 regular session is weeks away. Heyo! Regular session begins on Wednesday, January 3.

At the time of this report a total of 1032 have been filed. At this time last year, only about 750 bills had been filed. What's also odd is there are more bills filed in the Senate than in the House. It's usually in reverse. What's up with that..?

Legislation to be considered during the 2024 legislative session include everything from elimination of the personal property tax, property tax assessments, tax credit programs, sports wagering, video lottery terminals, foreign ownership of land, election and initiative petition reform, and tons of other bills affecting local governments and elementary and secondary education.

Joint Committee on Public Employee Retirement

The Joint Committee on Public Employee Retirement convened on December 1. Pension Analyst Robert Coleman provided a brief update regarding the quarterly report of the public pension plans. During the presentation, Coleman informed committee members that 45 plans were included in the report and most of the plans showed positive return and recovery after the volatility of 2022. Coleman then presented to the committee the pension watch list for the year

2023. Currently, there are thirteen plans on the watch list, which was noted to be more than the previous year but lower than expected given the volatility of 2022. He then provided a brief description of each plan and why they are on the watch list as well as what to expect going forward. Coleman made it a point to bring attention to two plans that appeared on the watch list, which were Poplar Bluff Police Retirement Plan and St. Louis Public School Retirement System. After discussing the watch list, the committee adjourned.

Tidbits

- This week Governor Mike Parson announced the annual state's Consensus Revenue Estimate (CRE) for Fiscal Year (FY) 25, which is a figure established by state budget experts and is one of the basic assumptions used by the Governor and legislative leaders to build and balance Missouri's budget. As part of those projections, they revised the anticipated estimate for the current year from a 7% increase, to a .7%. decrease. Net general revenue collections in FY25 are expected to be \$13.16 billion, which represents only a 0.2 percent net general revenue growth over the revised CRE for FY24. Governor Parson will outline his proposed FY25 budget during his annual State of the State address in January.
- On Monday, Governor Mike Parson named Trevor Foley as the new Director of the Missouri Department of Corrections. Foley has previously worked as a budget analyst for the Senate and has held various positions in the Department of Corrections, including the position of Deputy Director.
- On Tuesday, the Missouri Board State Board of Education announced they had unanimously voted to appoint Senator Karla Eslinger (R-Wasola) to serve as the new Commissioner of the Department of Elementary and Secondary Education. Senator Eslinger will be replacing retiring Commissioner Margie Van Deven who has announced she will be retiring effective July 1, 2024. The timing will allow Eslinger to complete the upcoming 2024 legislative session that ends in May. Senator Eslinger is a former school superintendent in southern Missouri who was elected to the State House of Representatives in 2018, and the State Senate in 2024.

Budget Update

The House Budget process for Fiscal Year 2025 is in full swing with the various sub-committees meeting this week to hear presentations from the departments regarding their Fiscal Year 2024 Supplemental Budget requests and the Fiscal Year 2025 Budget requests. The hearings this year have differed from those in the past as the departments gave high level overviews of their duties and successes, instead of going line by line through the budget books. This new format led to marathon hearings as committee members sought to find answers for their questions. House Budget leadership has announced they plan to deliver the House version of the budget to the Senate before the Legislative Spring Break in March to allow more time for the Senate to craft their version of the budget.

As the hearings progressed throughout the day and into the evening, the various Chief Financial Officers noted many of these department requests would change once Governor Mike Parson crafts his Executive Budget. This budget is typically released the third week of January after

Governor Mike Parson delivers his State of the State address. It should also be noted the deadline for the spending of most ARPA funding will be fast approaching so this will be the last year for an ARPA spending bill and many of those items will be reappropriation of already dedicated funding.

The DHSS appropriations subcommittee is scheduled to meet next week.
