On Tuesday, Congressman Jason Smith (R - Missouri) won his three-way race to chair the powerful Ways and Means Committee. Smith campaigned hard for this and this is big. Many politicos are wondering who will look out for MO now that Senator Roy Blunt (R - Missouri) is gone. One of the most important committees on Capitol Hill, Smith will oversee taxes, trade, Medicare and Social Security.

Stephen Webber is Back

Earlier in the week, former State Representative and Marine veteran Stephen Webber (D - Columbia) announced that he will be running for State Senate to represent Boone County in Senate District 19. Webber represented Boone County in the Missouri House of Representatives for eight years from 2009 to 2016. Senator Caleb Rowden (R - Columbia) can't run again in 2024 because of term limits. And the redrawn district only includes Boone County, where Webber won more votes than Rowden.

Webber is an attorney and currently serves as political director of the Missouri AFL-CIO, the state's largest federation of labor unions. Judy Baker, another former state representative who ran unsuccessfully against Rowden in 2020, told the Columbia Tribune last year that she is also weighing a possible run in 2024.

Gov Recommends a Wage Increase for State Employees

On Wednesday, Governor Mike Parson released the FY2023 Early Supplemental Budget. There were only two items within the early supplemental and include an 8.7% COLA increase for ALL state team members and an increase in shift differential to \$2 per hour for congregate care staff working within the Departments of Social Services, Corrections, Mental Health and Missouri Veterans Commission. These congregate staff must be working high-need and overnight shifts to be eligible for the \$2 per hour shift differential. The 8.7% COLA increase is based on the increase given to Social Security recipients this year and the Consumer Price Index determined by the U.S. Department of Labor's Bureau of Labor Statistics. This early supplemental budget pay plan proposal would invest \$151.2 million, including \$82.4 million in general revenue in the state workforce. Finally, Governor Parson has called on the General Assembly to take up and pass the early supplemental so it may be implemented by March 1, 2023.

Tidbits

- On Monday, Attorney General Andrew Bailey announced that he has recruited Maddie McMillian Green to serve as Deputy Attorney General for Policy. In this role, Green will handle policy, legislation, and stakeholder outreach for the office. Green previously served as Assistant Attorney General for Special Litigation under the Schmitt administration, handling litigation at the state and federal level.
- Also on Monday, Republic Scott Fitzpatrick was sworn in as Missouri's 39th State Auditor. He previously served as Missouri's State Treasurer and the Missouri House Budget Chairman. He replaces Democrat Nicole Galloway, who chose not to seek re-election. Fitzpatrick has stated auditing Missouri's K-12 public schools will be one of his top priorities. According to Fitzpatrick, he is the youngest statewide officeholder in America.
- Missouri Secretary Jay Ashcroft has submitted language to the Administrative Rules Division within
 his office that would implement disclosure standards pertaining to security investment strategies that
 propagate values-based agendas that are not purely focused on generating profit for their
 clients. The purpose of the proposed rule is to ensure financial transparency and require investment
 advisors to fully disclose and advise their clients of any investment strategy that is not purely financial
 based.
